1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. 2. The value selected in the bidding document is for bid creation purpose. All the Pre - Qualification Criteria and other requirement shall be as per the Buyer added Bid Specific ATC & the Excel sheet. Bidder to confirm & note the same.
